Resource & Investment NL (ASX: **RNI**) is pleased to advise that it has completed an issue of 4,000,000 ordinary shares at the issue price of 32 cents per share to sophisticated investor clients of Argonaut Securities Pty Limited, who come within one of the exemptions set out in section 708 of the Corporations Act 2001 (**the Act**).

The \$1,280,000 raised (before expenses of the issue) will be used to continue the Company's exploration activities and working capital.
